This agreement may be cancelled by written notice no less than 90 days prior to the date of performance by either party. Should unforeseen circumstances prevent Fifth Avenue Music from fulfilling this agreement, all deposits and payments shall be returned in full and this agreement shall be considered null and void. Should the buyer be prevented from fulfilling this agreement, all deposits and payments shall be forfeited and this agreement shall be considered null and void.

**9. Special Conditions:**

*I. - All outdoor event staging must be as per attached stage requirement sheet / Under cover / dry and include two (2) twenty amp electrical circuits. Outdoor event staging is the buyers' responsibility, unless otherwise negotiated and indicated on this agreement.*
